# Privacy Policy

## Obligations of the company

---

BCS Markets Ltd. (the Company) places a high priority on the privacy and integrity of the Personal Data of our Clients, both present and future and other visitors to the site. The Company strives to ensure the safety and confidentiality of all information received from the Client. This Privacy Policy (the «Policy») describes how the Company collects, uses and protects the Personal Data of the Client. This Policy does not require you to submit any more information than you have already provided to the Company if you are our Client, and in case of changes to the service provision by authorized representatives of the Company.

## The Client's Personal Data

---

To open up a demo or real account, the Company requires certain information about the Client. The information will be used for better understanding of the Client's needs and will help the Company to provide the Client with the services and the products that are more suitable for their needs. These data will also be used to improve the consulting services of the Clients.

The Personal Data that is collected by the Company may include (but not be limited to):

- 1) personal data that you specify in the requests forms, questionnaires and account opening requests: name, surname, address, date of birth, ID number, TIN, phone number, your occupation and current position etc.;
- 2) financial information such as your income, assets size, investment experience;
- 3) documents that will be used for person identification: passport, paid utility bills and/or bank statement or company's articles of incorporation;
- 4) documents confirming money transfer: payment vouchers, bank statements, credit card copies etc.

## Use of Personal Data

---

The Company may use the Client's Personal Data for one or more of the following purposes:

- 1) to confirm the Client's identity;
- 2) to process trading and non-trading operations;
- 3) execute the Company's policy against money laundering;
- 4) to inform the Client of Company products or services that may be of interest to the Client;
- 5) to provide other services that are relevant to the Client's relationship with the Company;
- 6) to keep a correct database of the Client's account data;
- 7) to analyze the data to provide the Clients with the most suitable products and services.

## Cookies policy

---

Cookies is a small text file sent by a web server that is stored on the Client's computer. The purpose is to enable the website to remember the Client's preferences. This file is sent to web server as an http-request, every time the Client opens the website page. Every time the Client visits the Company's Website, he/she will be prompted to accept or refuse cookies.

Cookies store information such as passwords (in an encrypted form), usernames, certain preferences, etc. allowing visitors to visit sites repeatedly without having to enter the same information over and over. Cookies are not used to determine the personal identity of anyone visiting the site.

The visitor can manage cookies policy and remove/delete already collected files without any restrictions on visiting the Company's website.

## Third Parties

---

The Company may convey the Client's Personal Data to associated or affiliated companies, auditors, agents (including payment agents), banks or other authorized organizations or persons («Authorized Persons») for the sole purpose of processing the Client's trading and non-trading instructions. The Company guarantees that all Authorized Persons will adhere to the terms of this Policy and take all necessary steps to protect the Client's Personal Data.

The Company may provide Personal Data to third parties, who are not the Company's partners, agents or affiliates, only when requested by the representatives of legal or administrative authorities.

### **Use of information**

---

By registering in Profile Area you give your personal consent to the use of your Personal Data and its processing: collection, recording, systematization, aggregation, storage (updating, changing) extraction, use, transfer (distribution, provision of access) anonymization, blocking, deletion, and destruction of any information relating directly or indirectly to you, your trade transactions and payments, in accordance with this Privacy Policy.

### **Security and protection**

---

BCS Markets Ltd. takes the security seriously and takes all possible measures to ensure the safety of the Client's confidential information. The Company adheres to the rules and standards of the internal use of confidential information and uses leading data storage technology. In order to make a payment with a bank card, you will be transferred to the processing center website, where you will fill in the payment form. To prevent the unauthorized use of your bank card, your card information is transmitted to BCS Markets Ltd. in shortened form and through a secure server.
